

HOW TO REGISTER FOR COIN ONLINE FOR TRADING LICENSE

1. On the homepage, for *e*-Citie, go to the Left Menu, under the **KCCA logo** and Select the type of registration that applies. COIN Individual/Non-Individual Registration



2. Click on the template you wish to fill out e.g. **COIN** Individual and select the reason for COIN application, which in this place is Trading License.
