

## **Invitation for Bids**

- 1. The *Government of Uganda has received* financing from the World Bank toward the cost of the *Second Kampala Institutional and Infrastructure Development Project (KIIDP2)*, and intends to apply part of the proceeds toward payments under the contract for *Procurement of enterprise storage*.
- 2. Kampala Capital City Authority now invites sealed bids from eligible bidders for *Procurement of enterprise storage*
- 3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's <u>Guidelines: Procurement of Goods, Works and Non-Consulting</u> <u>Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers</u> ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
- 4. Interested eligible bidders may obtain further information from **Kampala Capital City Authority**, **Procurement & Disposal Unit** and inspect the bidding documents during office hours 08:00 a.m. to 05:00 P.M. at the address given below.
- 5. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of Uganda shillings; Two Hundred Thousand (Ugx 200,000/=) only . Bidders are advised to collect Bank Payment Registration Slips at the address below and make payment to any of banks authorized to receive Non Tax Revenue fees on behalf of KCCA
- 6. Bids must be delivered to the address below on or before 10:00 a.m, 30<sup>th</sup> November, 2018. Electronic bidding *will not* be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on 30<sup>th</sup> November, 2018 at 10:10 a.m. (Local time)
- 7. All bids must be accompanied by *Bid Security* of *Uganda Shilling; Twenty million* (*Ugx* 20,000,000/=) only
