The Government of the Republic of Uganda (GoU) received financing from the African Development Bank towards the cost of the Kampala City Roads Rehabilitation Project (KCRRP), and intends to apply part of the proceeds of this loan to make eligible payments under the contract for "Consultancy services for the development of an Urban Design Manual for the Greater Kampala Metropolitan Area".

The main objective of the assignment is, in consultation with the current land use and planning standards and legal framework, and established international standards for urban design, to develop an Urban Design Manual for the Greater Kampala Metropolitan Area.

The specific objectives of assignment are to;

- i) Assess the current gaps in the existing land use standards and guidelines in the legal framework of Uganda;
- ii) Propose inclusive urban design standards and guidelines that locally respond to neighborhoods and develop green building standards including design elements, infrastructure, air quality etc.;
- iii) Develop standards for adaptation to improvement of infrastructure in lieu of the land tenure system;
- iv) Develop a holistic compliance monitoring plan for the city

Kampala Capital City Authority (KCCA), being an authorized agent of the Government of the Republic of Uganda now invites eligible Consulting firms to indicate their interest in providing the above services. Interested firms must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions in the region, availability of appropriate skills among staff, etc.)

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the "**Procurement Framework for Bank Funded Operations**" **approved**" October 2015, which is available on the Bank's website at <u>http://www.afdb.org</u>.

The short-listing criteria shall be as follows:

- i) A minimum of 10 years of regional experience in Urban Design/Urban Planning;
- ii) A minimum of 4 regional projects of similar scale or more, as the current assignment;
- iii) An appropriate combination of a minimum of the following disciplines; Urban Designer/ Planner, Landscape architect and Transport Planner.
- iv) At least five (5) years' experience in integration of climate resilience and transport with urban design
- v) Training and capacity building of at least five (5) years' experience for developed plans/manuals

Individual experts' bio-data is not required at this stage. Consultants may constitute joint-ventures to enhance their chances of qualification.
