		Reason for elimination:	
		Contrary to ITB 19.1 of the bidding document, which required all Bids to be accompanied by a Bid Security, their bid lacked a Bid Security.	
2.	M/s The Motorcentre East Africa Ltd.	Evaluation stage at which the bid was eliminated: Determination of substantial responsiveness	
		Reason for elimination:	
		Contrary to Section VII (3) of the bidding document (Technical Specifications) which required the oil type of air cleaner, the Bidder's technical brochures indicated the dry type of air cleaner, which is a material deviation.	

3.	M/s Construction and Farm Equipment Ltd.	Evaluation stage at which the bid was eliminated: Determination of substantial responsiveness
		Reason for elimination:
		Contrary to Section VII (3) of the bidding document (Technical Specifications), and the clarifications, which required a 2-wheel drive tractor, the Bidder offered a 4-wheel drive. This is a material deviation because, given the high fuel consumption of a 4WD, its poor maneuverability in small spaces, its high overall maintenance cost due to the more serviceable technical components, its total cost of ownership is high in the long run.

Display of this Notice does not constitute an acceptance of the bid described above or the formation of a contract.

Kampala Capital City Authority shall not sign a contract during the period of ten (10) days from the date of the notice. Formation of the contract shall be in accordance with the African Development Bank's Rules and Procedures for Procurement of Goods and Works (May 2008 Edition, Revised July 2012).
