Construction and Upgrade of Selected Roads in Kampala Capital City Authority: (Lot 1/ Lot 2/ Lot 3/ Lot 4/ Lot 5) – KCCA/GKMA/WRKS/2024-2025/00010 – LOT 1/2/3/4/5

The Government of Uganda through the Ministry of Kampala Capital City and Metropolitan Affairs (MKCC&MA) has received funding from the **World Bank/International Development Association (IDA)** to implement the **Greater Kampala Metropolitan Area-Urban Development Program (GKMA-UDP)**. **Kampala Capital City Authority** as a participating entity has been allocated funds under the program for the Upgrading and Reconstruction of selected roads to bituminous standards.

1. Kampala Capital City Authority invites sealed bids from eligible bidders for the provision of the above works.
2. Bidding shall be conducted in accordance with the Open Bidding procedures contained in **the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) – Order 2021** and the Regulations made under the Act, and is open to all eligible bidders.
3. Interested eligible bidders may obtain further information and inspect the bidding document **at the address given** at 6(a) **from 8:00 am to 5:00 pm** from Monday to Friday except on Public Holidays.
4. Bidding Documents in English may be purchased by interested bidders upon the submission of a written application to the address indicated in 6(b) below and upon payment of a non-refundable fee of **UGX.500,000/=** (Five Hundred Thousand Shillings) only, **per Lot**. The method of payment will be by obtaining a payment reference number (PRN) after which a general receipt shall be issued from **Kampala Capital City Authority, Procurement & Disposal Department**. The bidding document shall be issued by the Procurement and Disposal Department (PDD) upon presentation of the general receipt at the address given at 6(b).

Bids must be delivered to the address at 6(c) on/or **before 25th September 2024, 11:00 am**. All bids must be accompanied by a bid security of Uganda Shillings: **(please refer to the table below)**.
