Conservationists worry over extinction of tree varieties

Recent reports indicate that the Afzelia tree species is facing extinction. Even the encyclopaedia of life has branded the variety as vulnerable due to its popularity among

But it is not the only tree facing extinction in Uganda.

Simon Peter Achuu, a plant conservationist, said many other tree species face similar fate and ecologists were concerned the varieties could cease to exist, should nothing be done.

Achuu made the remarks at Esella Country Hotel in Wakiso district last week, where environment leaders converged to discuss biodiversity and potential desertification in

"These trees are of high value. People literally 'hunt' them the entire time. But no one is bothered," Achuu, who is also a project manager for the UNDP Global Environmental Finance (UNDP-GEF) Rio Conventions Project that seeks to train local authorities regarding the country's commitment towards conserving the environment, said.

What shall we tell our grandchildren after we have wiped all diversity and turned Uganda into a desert?" Achuu asked.

Afzelia is predominant in northern Uganda, same as Vitellaria Paradoxa (shea tree). Tamarind (Enkoge), is mainly grown for its

indehiscent, sub-cylindrical brown pod fruits. The tree can be found scattered across the country, especially towards the eastern part of the country.

The desert date, scientifically known as Balanites aegyptiaca, is a highly valuable tree mainly found in West Nile, Teso and Karamoja sub-regions, where it is known by local names including Logba or Lugba (among Lugbara and Madi), Thoo (Alur), Ecomai (Ateso), and

Ekorete (Ngakarimojong).

The date-like fruits of the balanite tree have a bitter-sweet, yellowish-red pulp. The ripe fruits are eaten raw or sun-dried and can be safely stored and sold as desert dates. Its pulp is rich in sugars, vitamins and a range of essential minerals. In Teso and Karamoja, its freshly growing leaves are used as vegetables.

The fruit pulp can be soaked in water to create a tonic, which can be fermented to make

Mabira forest, which itself is under threat.

"We are not doing enough to protect the environment, especially the endangered species," James Ateker Okiria, the project manager of Kidepo Critical Landscape that overseas conservation and sustainable use of the threatened savanna woodland in the area,

He said the Police, who are meant to protect the vulnerable varieties, connive with illegal

The Government banned the cutting, transportation and sale of Afzelia Africana logs and suspended the felling of varieties classified

as vulnerable in late 2016.

Despite directives from President Yoweri Museveni banning the cutting of the Afzelia Africana tree, the cutting continues unabated in West Nile.

This is partly a result of a very lucrative market for the logs (especially Afzelia Africana logs) in some Asian countries. Shea trees are cut and burnt for charcoal and its fruits used in making lotions and other food supplements.

"We have a weak and corrupt enforcement."

Okiria, said, calling for the amendment of the National Environment Act so it is "deterrent

However, Achuu said a revised environment Act, which is before Parliament, would address the 'gap'.

"The challenge is the trees cannot just be replanted," Okiria said, adding: "One cannot say they are going to shift seedlings of the Afzelia and plant them in other parts of the country. A soil composition study to see if it is suitable has to be done first."

The meeting focused on the Rio Convention and strengthening of institutional capacities for effective implementation of the agreements on biodiversity, climate change and desertification.

Uganda is party to the 1992 Earth Summit resolutions, held in Brazil's capital, Rio de Ianeiro.

"All of humanity has a role to play so that another tree is planted and another water body preserved, while wetlands are conserved," Godwin Kamugisha, the principal environmental economist at the National Environment Management Authority, said.

Accidents leading cause of blood shortage in Uganda, says Balimwezo

Uganda is among 25 countries in the world with the highest number of fatal accidents, leading to blood scarcity in the country, Ronald Balimwezo, the mayor of Nakawa Division, has

He made the remarks while launching a sixday blood donation drive at Nakawa market yesterday.

He said most of the accident victims found in medical facilities are those caused by bodaboda riders and reckless car drivers.

"I lost a lot of blood when I got an accident in which I broke my leg but thanks to people who donated their blood to save my life," Balimwezo

He called upon the Government to address causes of accidents and also cautioned bodaboda riders and vehicle drivers against recklessness, in order to save lives.

He also urged the public to donate blood, in order to curb the scarcity of blood in the country. According to a United Nations report, Uganda

loses 10 people to road accidents everyday Michael Mukundane, the National Blood bank co-ordinator in charge of donor recruitment, said Uganda has an annual demand of about 340,000 units of blood, but falls short by over 100,000 units.

About 600 pints of blood are needed to meet the gap that is in the country, which is expected to be collected within six days of the blood

He added that students are the leading blood donors because they are easy to mobilise and are found in schools compared to the community

members that are in different places.
"We normally do community mobilisation when students are in holidays, to meet our monthly target," Mukundane said.

Speaking on behalf of the director of Uganda Blood Transfusion, Mukundane said the blood bank needs 1,200 units of blood to meet the country's demand.

"We call upon the public to join the drive to donate blood to save life," Mukundane said.

Limited communications and sustainable manager, said anyone above age of 17 and weighs above 45kg is eligible to donate blood.
