The debriefing shall be in writing. We shall promptly advise you in writing how the debriefing will take place and confirm the date and time.

If the deadline to request a debriefing has expired, you may still request a debriefing. In this case, we will provide the debriefing as soon as practicable, and normally no later than fifteen (15) Business Days from the date of publication of the Contract Award Notice.

In any event, the Bank reserves the right to review any complaint of a bidder at any time following the award.

## 5. How to make a complaint
