

## **Executive Director KCCA:**

### **Ongoing Evacuation Program of Street Vendors in Kampala starting Date: 13th February 2026**

#### **1. Opening Salutation & Appreciation**

- Greet the people of Kampala.
- Appreciate citizens and businesses for cooperation despite the looming challenges.
- Some of the on going operations in the City include; decluttering of electoral material, Paving & Greening frontages and Implementing Trade Order in the City.

#### **2. Purpose of this engagement:**

You recall that during the Media briefing on 5<sup>th</sup> February 2026, Hon. Minister for Kampala Capital City and Metropolitan Affairs, Hajjat Minsa Kabanda observed the need to restore Trade Order in the City and directed that implementation takes effect on 19<sup>th</sup> February 2026.

#### **3. Objective of this operation:**

- To restore trade order in the city.
- To ensure Consumer Protection in the city
- To establish a safe and profitable working environment for legitimate and taxpaying business operators.
- Ensure hygiene and sanitation in the city.
- Protection of city infrastructure, roads, walkways, drainages, street furniture, green spaces and the overall aesthetics/beauty of the city.

#### **3. Implementation of the directive**

- The operation shall be led by the KCCA enforcement team in their full uniform (Blue) with clear uniform identification numbers with support from other security agencies.
- Persons or vendors/hawkers who are found, illegally trading in walkways, roads, ungazetted places like; road islands and medians shall have their goods impounded, they may be apprehended and arraigned in courts to determine their fate.
- Our enforcement officers shall be in place to continue dominating, engaging, and continuously enforcing trade order in the city.

#### **4. Public feedback**

## 10.Criteria & Process for Getting a Stall in a Market in Kampala

- Vendor registration with KCCA or market management.
- Verification of trader category and goods sold.
- Proof of Former Street vending activity (where applicable).
- Priority consideration for:
  - Previously registered vendors
  - Vulnerable groups (women, youth, PWDs where policy applies)
- Allocation through:
  - Application is made to the Market allocation Committee
- Issuance of stall/space allocation confirmation.

## 12. Closing Lines:

- KCCA is engaging vendors and leaders continuously.
- Objective is orderly trade — not loss of livelihoods.
- Appeal for continued cooperation and dialogue.
- **City order benefits everyone.**
