Notice of Expression of Interest for the provision of consultancy services for an Integrated Faecal Sludge Management Information System Consultancy Services (Firm)

- 1. Kampala Capital City Authority has received funds from the Bill and Belinda Gates Foundation (BMGF) and the Department for International Development (DfID), to partly be used for the acquisition of the consultancy services described below.
- 2. The Entity now invites eligible consultants to submit sealed expressions of interest for the implementation of the Kampala Faecal Sludge Management (FSM) project. The project seeks to improve FSM in the vulnerable urban poor areas of Kampala city through an efficient and affordable private sector led service delivery model.
  - The objective of the consultancy is to develop an Integrated Faecal Sludge Management Information System for the project. The consultancy is initially required for six (6) months and is subject to renewal. The conditions for renewal of the contracts are; successful performance, availability of other assignments and funds throughout the subsequent duration of the project.
- 3. Interested consultants should provide information demonstrating that they are eligible and possess the required qualifications to perform the services supported with relevant documentation.
- 4. The short listing criteria will include:

## Eligibility

- a copy of the trading licence of the consultant or its equivalent;
- a copy of the certificate of registration of the consultant or its equivalent;
- a signed statement indicating that the consultant does not have a conflict of interest in the subject of the procurement;
- evidence of fulfilment of obligations to pay taxes and social security contributions;
- the consultant is not suspended by the PPDA or any other regulatory entity;

## Qualifications

## The firm must have;

- A minimum of five (5) years in IT business solutions
- ISO certification
- Handled at least two (2) projects of similar nature. Each project should be accompanied with verifiable authentic evidence of successful completion and

operation.

- A locally registered technical services support centre
- The following key personnel; and their minimum qualifications
  - i. Project Manager
  - ii. GIS Specialist
  - iii. IT Software Development Specialist
  - iv. Network Engineer
- 5. Consultants may associate with other firms in the form of a joint venture to enhance their qualifications. The form of association, where applicable, should be indicated in the Expression of Interest.
- 6. Preference schemes shall apply when evaluating Request for Proposals from the shortlisted consultants.
- 7. Interested eligible consultants may obtain further information at the address given below from 8:30 am 4:30 pm on working days.
