KCCA intends to apply part of the maintenance fund to pay for services under Frame work contract for Routine Road elements Repairs using Portland cement based products and methods for a period of eighteen (18) Months.
- 2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding Method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
