



## BID NOTICE UNDER OPEN DOMESTIC BIDDING

1. Uganda Revenue Authority has committed funds for **Upgrading of Walusimbi Road to Bituminous Status (0.37km in Nakawa Division). (Procurement Ref: KCCA/WORKS/16-17/00766)**
2. Uganda Revenue Authority requested Kampala Capital City Authority for technical assistance during the procurement and construction of the road
3. Kampala Capital City Authority invites sealed bids from eligible bidders for the implementation of the above works.
4. Bidding will be conducted in accordance with the Open Domestic Bidding Procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.
5. To qualify for award, the Bidder must meet the following minimum qualifying requirements:
  - General Construction experience of not less than six years as contractor
  - Minimum average annual construction turnover of not less than Uganda Shillings: Three billion (Ug. Shs 3,000,000,000/=) equivalent over the last four years.
  - Experience as contractor in at least 2 (two) similar road contracts of the same complexity and value within the last 3 (three) years, each with a value of at least Ug.Shs Two billion (2,000,000,000) that have been successfully completed, OR as indicated in the evaluation criteria.
  - Capacity to access a cash flow amount of Uganda Shillings: Five Hundred Million (Ug.Shs 500,000,000/=) or equivalent.
6. Interested eligible bidders may obtain further information from Kampala Capital City Authority and inspect the bidding documents at the address given below in No. 10 (a) from 8:00am to 5:00pm, Monday to Friday except on public holiday.
7. A complete set of bidding documents in **English** may be purchased by interested bidders on the submission of a written application to the address given below in No 10 (a) and upon payment of a non-refundable fee of **Ushs 150,000/-** (Uganda Shillings, One hundred and fifty thousand only). Bidders will only be issued with Bidding Documents upon presentation of an original receipt of payment. The documents shall be physically collected from the address in 10 (a) below.
8. Bids must be delivered and registered to the address in No.10 (c) at or before **11:00AM, on 4<sup>th</sup> August, 2017**. All bids must be accompanied with a bid security of **Ushs 15,000,000/=** (*Uganda Shillings fifteen million only*) in form of a Bank Guarantee from any recognized

commercial bank in **Uganda**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below in No 10(b) at **11:30AM on 4<sup>th</sup> August, 2017**.

9. There shall be a pre-bid meeting on 26<sup>th</sup> July, 2017 at 11:00 am at URA IT Board room followed by a site visit on same day
