- 3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

- 6. Bids must be delivered to the address below at 8(c) at or before 4th November, 2016 at 11:00am All bids must be accompanied by a bid security of Uganda Shillings; Forty Million (UGX 40,000,000). Bids must be valid until 28th April, 2017. Bid securities MUST be valid until 7th June, 2017. Late bids shall be rejected.
