



Invitation for Bids

1. The *Government of Uganda* has received financing from the World Bank toward the cost of the *Second Kampala Institutional and Infrastructure Development Project (KIIDP2)*, and intends to apply part of the proceeds toward payments under the contract for *Procurement of Software*

2. The *Kampala Capital City Authority* now invites sealed bids from eligible bidders for *Supply of Hardware Equipment to KCCA in lots*

Lot 1: GIS Equipment: 25 No. Integrated Data Collection Equipment, 20 No. Mobile Navigation Devices, 10No. Integrated handheld data collection equipment with range finder

Lot 2: 10 No. Desktop Computers, 01 No. Complete Interactive White Board System, 100 No. Two Way Radios (a.k.a Walkie Talkies), 8 No. Repeaters and 4 No Television Screens

Lot 3: Supply and Installation of Two (2) GIS Enhancement Servers and a Server Chassis

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's [Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers](#) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

Bidders are advised to collect Bank Payment Registration Slips at the address below and make payment to any of banks authorized to receive Non Tax Revenue fees on behalf of KCCA
