**Lot 1:** Consultancy Services for Design Review and Construction Supervision for Signalisation of 3 junctions, Upgrading and Underpass Construction of 2 km, and Recycle, Overlay of 7.8 km and signalisation of 2 Junctions, all in Makindye Division

**Lot 2:** Consultancy Services for Design Review and Construction Supervision for Design Review and Construction Supervision for Reconstruction, Dualling, Bridge Extension and signalisation of 4 Junctions of 6.7 km, Dualling and signalisation of 2 Junctions of 3.4 km, Upgrading to Paved of 3.1 km, Reconstruction & Dualling of 2.8 km, all in Nakawa Division and Reconstruction & Widening of 1.75 km in Central Division

**Lot 3:** Consultancy Services for Design Review and Construction Supervision for Design Review and Construction Supervision for Recycle, Overlay & Dualling of 3.4 km in Kawempe Division, Recycle, Overlay & Dualling of 4.2 km in Rubaga Division, Upgrading to Paved of 8.5 km Beyond KCCA area, Upgrading to Paved of 17km in Rubaga Division, and Dualling and signalisation of 3 Junctions of 2.4 km in Kawempe Division

The **Kampala Capital City Authority received** financing from the World Bank toward the cost of the (**KIIDP2**, and intends to apply part of the proceeds towards consulting services.

The consulting services ("the Services") include provision of consultancy services for carrying out design review and construction supervision for upgrading of key road junctions, upgrading and dualling of major Kampala City road links. The assignment for Lot 1 will be carried out over a period of thirty two (32) months and thirty six (36) months for Lot 2 and thirty six (36) months for Lot 3, all including a 12 months defects liability period.

The **Kampala Capital City Authority** now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services including brochures, organizational set up. The short listing criteria will be as follows:

- 1) General experience of the firm in at least fifteen (15) assignments in infrastructure engineering studies, design and construction supervision;
- 2) General experience of the firm in supervision of infrastructural projects in the sub Saharan Africa region on at least five (5) projects.
- 3) Relevant experience of the firm in at least ten (10) assignments of similar nature and scope;
- 4) Availability of appropriate skills/expertise among the consultant's staff including Resident Engineers, Highway/Pavement Engineers, Transport planners and traffic engineers, Materials Engineers, Bridges/Structural Engineers, Engineering Surveyors, Measurement Engineers, Electrical Engineers, Urban Traffic Control Engineers, and Social and Environmental Experts.

Individual experts' bio-data is not required.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines:* Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers January 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consulting firms may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. The type of association whether a joint venture or a sub-consultancy, where applicable, must be clearly indicated in the Expression of Interest.

Consulting firms may express interest in one or more lots. Consultants expressing interest in more than one Lot should demonstrate qualifications, experience and capacity to execute the Lots for which they submit an Expression of Interest. A Consultant may be short listed for more than one lot provided the Consultant can demonstrate qualifications, experience and capacity to concurrently execute the lots for which they are short listed.

A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
